Corporate Governance Statement – 2024

This Corporate Governance Statement is dated 30 June 2023 and was approved by the Aguia Resources Limited (**Aguia** or the **Company**) Board (the **Board**) on 27 September 2024. 			Environmental: The Company engaged independent firm Golder to perform the EIA – Environmental Impact Assessment – of our Phosphate Project. This extensive program took more than 2 years to be completed and

			covered every single aspect of the Directly Affected Area of the Project and also included a social-economic and an archaeological survey. The results of this program were all filed at the State Environmental Agency as part of the permitting process and resulted in the granting of the LP, the first stage and more complex level of the permitting process.
			The Company is planning to produce a Natural Fertilizer, which does not require any water resources for its production, does not require the addition of chemicals and does not generate any tailings. This results in a very environmentally friendly process and product.
