# QUARTERLY ACTIVITIES REPORT 30 SEPTEMBER 2024

## HIGHLIGHTS

- The Company raised \$5.1m through the issue of approximately 204 million new fully paid • ordinary shares in the Company at \$0.025 per share
- The Company listed on the Frankfurt and Stuttgart Stock Exchanges on 23 September 2024 after strong investor support in Germany and Switzerland
- Recommissioning works at the Santa Barbara Gold Project in Colombia continued during the • quarter.
- Ongoing development of the Company's phosphate assets in Brazil with continued negotiations for treatment of the Company's phosphate resources through leasing, purchase and toll treatment arrangements.
- Subsequent to the close of the Quarter the Company achieved a successful outcome in the • Brazilian courts whereby has denied FPPO's (Federal Public Prosecutors' Office) request to annul the previous license granted by FEPAM (the Rio Grande do Sul State EPA) to Aguia for the Fosfato Três Estradas project, meaning there is no longer any impediment to the advancement of the Tres Estrades phosphate project.
- As Aguia continues along the path of revival and rebuilding the Company has decided to update the company logo as part of the renewal process.

Sydney, Australia: Aguia Resources Limited ABN 94 128 256 888 (ASX:AGR) ('Aguia' or the 'Company') is pleased to report on its activities for the September 2024 Quarter (the 'Quarter').

During the guarter the Company raised A\$5.1 million through the placement of approximately 204 million shares to fund ongoing activity in Brazil and Colombia.

The Company advised the market on 23 September that AGR is now listed on the Frankfurt and Stuttgart Stock Exchanges. Continued promotion and interest in Agua's South American assets in Europe was a catalyst to list the Company in Europe to satisfy demand.

In Colombia, the Company continued with the rehabilitation of the existing mine and processing facilities at the Santa Barbara project. The Company expects exploration development and processing through the existing pilot plant to commence in November 2024.

In Brazil, the Company continued negotiations with three parties in relation to potential deals to treat Company phosphate resources in existing processing facilities. Discussions on the potential to lease an existing processing facility and have phosphate ore toll treated through a second facility advanced during the quarter.

In Brazil, Subsequent to the quarter end, and as announced on 25 October 2024, The Federal Court Trial Court of the City of Bagé, the State of Rio Grande do Sul has denied FPPO's request to annul the previous license granted by FEPAM to Aguia for the Fosfato Três Estradas project finding that:

- The family ranchers do not fall under the concept of traditional community and, as such, no previous, free and informed consultation is mandatory, and
- The public hearing that took place met the legal requirements and was attended by populations from Dom Pedrito and Torquato Severo, reason why there would be no need to nullify the environmental license proceeding to have additional public hearings.

The effect of this decision is to reject the application for an injunction that has been under consideration for approximately three years, from July 2021. Aguia is now free to continue advancing the Tres Estrades Project under the already granted Installation and Environmental Licences. Under Brazilian Law, the next step is the preparation of the site for first production. Once the site has been prepared pursuant to the existing environmental approvals, the State Environmental Protection Foundation FEPAM will issue the Operational Licence and commercial mining operations can commence. Aguia anticipates this process will take 3-6 months to complete.

During the quarter the Company released the 2024 Full Year Statutory Financial Statements and Corporate Governance Statement to the market. The Company continued the closure of the compulsory acquisition process for the remaining Andean Mining Limited shares. Of the 29 holders subject to compulsory acquisition 7 have now signed the transfer documentation a further 3 holders have been sent transfer documentation. We are endeavouring to contact the remainder.

As Aguia continues along the path of revival and rebuilding the Company has decided to update the company logo as part of the renewal process. This new logo reflects our business of drilling into the earth to unlock the valuable mineral products. All mining commences with exploration drilling in the first instance. We hope that shareholders will grow to recognise and respect this logo and see it as being synonymous with the success to which we a rapidly progressing.

#### **Capital Raising**

On 26 July 2024 Aguia announced the placement of 104,000,000 fully paid ordinary shares at \$0.025 per share to raise \$2.6m before costs. Subsequently, on 30 August 2024 Aguia announced an additional placement of 100,000,000 fully paid ordinary shares at \$0.025 per share to raise \$2.5m before costs.

Funds raised will be allocated to the recommissioning of the existing 30 tpd (tonnes per day) treatment plant. Aguia will also commence preparations for brownfields exploration drilling at Santa Barbara, which is intended to enable a maiden JORC resource to be declared. Placement funds will also be deployed to advance development of the Company's phosphate assets in Brazil.

During the quarter, Aguia made the following advancements across Andean's asset portfolio in Colombia and its phosphate projects in Brazil.



## **COLOMBIAN ASSET PORTFOLIO**

#### Santa Barbara Gold Project

During the Quarter the company continued to make progress on equipment purchases and employment of personnel to restart the Santa Barbara and Mariana underground development and processing plant.

The upgrade to facilities on the site included construction of extension to the accommodation and the purchase of containerised buildings including a kitchen, bathrooms, offices, stores and accommodation.

The EIA documentation for the Santa Barbara licence # 0-439C1 has been reviewed and accepted by the ANM and a "Concepto Tecnico Favorable" (CTF) has been issued. The issue of the CTF is a precursor to the issue of the EIA licence, which is the final approval required to commence operations.

Ahead of the issue of the EIA the company has entered into an operations agreement to purchase explosives for the project. Once the EIA approval is received the Company will be entitled to purchase explosives for its mining operations directly from the Colombian National Army.

#### **Exploration Diamond Drilling**




Figure 1 Collar locations

A first phase diamond drilling program, to commence in February 2025, has been designed for the Santa Barbara and Mariana vein systems to explore the strike and dip continuity of the vein systems and to test areas outside of the known vein systems for additional vein sets. The drill pads selected are mostly located in accessible areas with moderate slopes that do not present significant challenges for drill pad construction. See Figure 1 below.

Note: The drillholes and platform locations may be adjusted as the drilling program progresses and more information becomes available.

There are two main components to the drilling program:




Figure 2 Planned drill collar locations, Santa Barbara tunnel outline and structural data measured.

 Resource Definition drilling on the Santa Barbara and Mariana vein systems which is aimed at delivering a maiden resource estimate and supporting the preliminary exploration development plans. The main goal of the drilling is to understand the variations in dip and strike direction of the known veins given that the veins are directly related to right lateral strike-slip faults and will follow the same structural movement patterns. Drilling is designed to confirm the distribution of gold mineralization and its continuity for grade control, underground development planning and ultimately for grade and tonnage estimation. Planned diamond drilling on the Santa Barbara vein system. (Figure 2 and Tables 1 and 2)




Figure 3 Santa Barbara proposed pads and drillholes vs Santa Barbara main vein






Figure 4. Long section view of the Santa Barbara drilling

There are 21 proposed drill holes for an estimated total of 2.044 m of drilling. The drilling program is designed to intersect the target main vein at depths of 25m and 50m below the tunnel level. The tunnel portal has an elevation of 200masl, and the first drilling grid line is set at 175masl and the second at 150masl. (Figures 3 and 4)




Figure 5 Drill collars location – MarianaVein with structural data measured in the tunnel.




Figure 6 Long section view of the drilling grid design.

Drilling on the Mariana vein from surface is restricted by topography, however, drilling from the crosscut which will be developed from the Santa Barbara vein system to connect to the Mariana vein system will provide a platform from which to assess the Mariana vein system below the old workings.(Figure 6)

2. Exploration drilling, oriented towards locating additional mineralization in parallel vein sets outside of the planned underground development. At this early exploration stage and based on the number of veins identified at surface, exploration drilling from the same drill pads used to drill the Santa Barbara and Mariana vein systems will be used to intercept additional veins beyond those already mapped. This will also provide valuable geological information on each structural block, as the geological model indicates imbricated structural domains of down faulted blocks with the same veins repeated in adjacent faulted blocks (tectonic blocks). 


Figure 7 Proposed Phase 1 Exploration drillholes.

## Atocha Silver Gold Exploration Project

During the quarter the Company completed planning for a surface exploration program consisting of surface geological mapping and soil, stream and rock chip sampling covering the northeastern quadrant of the project area as a follow up to a previous discovery of two high-grade gold-silver veins in the Jimenez Creek. Surface prospecting covering the eastern side of the Socorro Creek where the 'Veta Grande' sub outcrop is located will also be examined.

Subsequent to the end of the quarter Outcrop Silver Corp. (TSX.V: OCG) (Outcrop) of Canada made an announcement to the TSX.V regarding a discovery on the La Ye vein at its Santa Ana project in the Department of Tolima, Colombia. Information released by Outcrop indicate drilling and channel sampling in close proximity to the northern boundary of Aguia's Atocha project. Atocha's previous operator (Baroyeca Gold & Silver Inc) conducted diamond drilling at Atocha on the La Ye vein indicating continuous gold/silver mineralisation over a strike length of at least 400m in multiple parallel veins. ## El Dovio Project (Titles IEH-08441 and IEH-08401)

There are no new actions or notifications reported by the Mining Authority on title IEH-08441 and IEH-08401. The Company will conduct surface sampling and geological mapping in the surrounding areas to the known targets at EI Dovio, with planned commencement of those activities in 2025. Two drill holes from previous campaigns were not sampled. Sampling of these holes has been completed and the samples sent to SGS laboratory in Medellin, Colombia for assay.



The company has applied for an extension of the exploration stage as is required by legislation. The company is also proceeding with the withdrawal of the westernmost area of Mining Title IEH-08441 which extends into the Department of Choco as there are a number of restrictions to mining in this department that will prevent development.

The company filled the withdrawal of the westernmost area from Mining Title IEH-08441overlapping the Choco Department as mining in this Department is covered with several restrictions that will prevent development, exploration and expansion in that direction.

#### BRAZIL PHOSPHATE DEVELOPMENTS

#### Exploration and Resource Definition Drilling at Mato Grande

During the quarter, Aguia completed an auger drilling program at its second 100%-owned phosphate project, Mato Grande, designed to extend the known phosphate mineralisation within the shallow saprolite zone (refer ASX Announcement 2 May 2024).

The drilling program consisted of 140 auger holes for a total of 660 meters with 90% of the assays received.

Early agronomic tests have indicated the Mato Grande phosphate ( $P_2O_5$ ) in the production of rye grass is performing better than the imported superphosphate from Morocco and the Tres Estrades Pampafos.

Aguia has contracted German Group DMT to prepare the end of exploration report which is required to enter into the development phase. Aguia plans to commence with initial development phase works in Q2 2025.

#### Exploration and Resource Definition Drilling at Passo Feio

During the quarter, Aguia commenced an auger drilling program at its third 100%-owned phosphate project, Passo Feio, designed to extend the known phosphate mineralisation within the shallow saprolite zone. The drilling program has continued into the Q2 2025. Initial results indicate that the Passo Feio saprolite phosphate zone is developed to a greater depth with generally higher  $P_2O_5$  grades than what was intersected at Mato Grande.

#### **Licence Acquisitions**

Aguia participated in a government bidding process for 2 licences along strike from the Company's Passo Feio licences and was successful in its bid to purchase the licences from the government. The two licences 810264/2010 and 810550/2008 indicate strong geophysical, geological and  $P_2O_5$  sampling results provide evidence that the Passo Feio carbonatite trend continues to the north east of the known mineralised carbonatites. 


Figure 8 Passo Feio targets on licences acquired in the bid process

## Potential Alternative P<sub>2</sub>O<sub>5</sub> Processing Facilities

During the quarter Aguia's Brazilian based team have continued negotiations to either acquire, lease or have Aguia's phosphate toll treated in a number of processing facilities in the Cacapava do Sul area within the State of Rio Grande do Sul. Discussions with relevant parties are ongoing.

At this time the Company has no further information with which to update shareholders with respect to the Public Civil Action which is continuing to delay the Tres Estrades Project. As previously reported, we remain optimistic of the outcome, based on the merits of our case as we wait for a judgement to be delivered by the Federal Court.



## **EXPENDITURE AND CASH BALANCE**

Operating expenditure during the Quarter totalled A\$1,931,000, which included A\$659,000 for exploration and evaluation activities.

During the Quarter, A\$73,000 in payments were made to related parties of the Company. These payments were to Directors of the Company in the form of Director's fees and salary payments. In addition, \$137,500 was paid to Far East Capital, in relation to the fees associated with the completion of the \$2.5m Private Placement as announced on 30 August 2024. Mr Warwick Grigor is a director of this company. At the end of the Quarter, the Company had a cash balance of A\$3,602,000

#### **OTHER INFORMATION**

During the Quarter there were no substantive mining exploration activities and there were no substantive mining production and development activities.

As previously reported, the extension of license and exploration of tenements 811294/2015 and 811549/2015 were denied. Aguia is appealing the ANM decision. No new tenements were acquired between 1 April 2024 and 30 June 2024. In addition, there were no farm-in or farm-out agreements entered into during the quarter.

**Executive Chairman, Warwick Grigor, commented**: "During the quarter, Aguia made solid progress on the stated growth strategy for its portfolio of South American assets and it raised sufficient capital to execute its plan. Operations were highlighted by the completion of the acquisition of Andean Mining, and the Company is now focused on the development of the Santa Barbara Gold Project in Colombia and our phosphate assets in Brazil. We look forward to providing more updates in the second half of 2024 as these developments progress."

Aguia Resources Limited ("Aguia") is an ASX-listed multi-commodity company (AGR:ASX) with a preproduction phosphate project and extensive copper exploration targets located in Rio Grande do Sul, the southernmost state of Brazil. Aguia has an established and highly experienced in-country team based in



Porto Alegre, the capital of Rio Grande do Sul. Aguia is committed to advancing its existing projects into production whilst pursuing other opportunities within the sector.

On 22 December 2023 Aguia announced the proposed takeover of 100% of unlisted public company Andean Mining Limited which has a portfolio of 100%-owned, high-grade gold, silver and copper projects in the Republic of Colombia, South America:

- **Santa Barbara Gold Mine:** high-grade mesothermal gold project with a 30 tonnes per day pilot plant that has treated 500 tonnes of ore, with average recoveries of 20 g/t Au; early cashflow opportunity.
- **Atocha:** high-grade silver/gold exploration project with reported drill intercepts that include 20.14g/t Au and 723g/t Ag (29.0g/t AuEq) over a true width of 0.8m in drill hole AT-21-02.
- El Dovio: high grade copper/gold project: VMS-style mineralisation, with 34 drill hole intercepts that include 8.14g/t Au, 6.92% Cu, 39.41g/t Ag and 1.46% Zn over 5.80 metres in drill hole D13-05 and an exploration adit having been completed.
