## **ASX LISTING RULE 3.10.5A AND 7.1A.4(b) NOTICE – SHARE ISSUE**

Agua Resources Limited (ASX: **AGR**) (“Agua” or “Company”) hereby provides notice to the ASX for the purposes of ASX Listing Rule 3.10.5A and section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) that on 9 July it issued 31,710,000 ordinary shares in the Company, of which 13,550,000 ordinary shares were issued in accordance with ASX Listing Rule 7.1A.

As previously notified, the Directors of the Company have committed to a further 2,050,000 shares to be issued following approval of shareholders.

The Company states pursuant to the provisions of ASX Listing Rule 3.10.5A that:

- The placement represented 8.10% of the expanded ordinary shares on issue of the Company, resulting in a dilution to the existing holders of ordinary securities by that amount;
- The Company considered the placement as the most efficient and expedient method for raising the funds required by the Company for its working capital purposes. As the placement was conducted at a premium to the previous 15 day trading day volume weighted average price (calculated in accordance with ASX Listing Rule 7.1A.3) for the Company’s ordinary shares. The Company has also announced that proposes to offer shareholders the opportunity to participate in a capital raising on the same terms as the placement via share purchase plan, with further details to be released in the coming weeks;
- The placement was not underwritten; and
- No fees are payable in relation to the placement of 13,550,000 ordinary shares that were issued in accordance with ASX Listing Rule 7.1A.
