ASX LISTING RULE 3.10.5A AND 7.1A.4(b) NOTICE – SHARE ISSUE

Agua Resources Limited (ASX: **AGR**) (“Agua” or “Company”) hereby provides notice to the ASX for the purposes of ASX Listing Rule 3.10.5A and section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) that on 10 February 2014 it issued 21,484,175 ordinary shares in the Company, of which 18,349,041 ordinary shares were issued in accordance with ASX Listing Rule 7.1A.

The issue price per share was \$0.06, making a total issue consideration of \$1,289,051.

As previously notified, the Directors of the Company have committed to a further 4,000,000 ordinary shares, to be issued following approval of shareholders.

The Company states pursuant to the provisions of ASX Listing Rule 3.10.5A that:

- The placement represented 8.95% of the expanded ordinary shares on issue of the Company, resulting in a dilution to the existing holders of ordinary securities by that amount;
- The Company considered the placement as the most efficient and expedient method for raising the funds required by the Company for its working capital purposes, as the placement was conducted at a premium to the previous 15 trading day volume weighted average price (calculated in accordance with ASX Listing Rule 7.1A.3) for the Company’s ordinary shares;
- The placement was not underwritten; and
- Applications for 9,750,000 ordinary shares were made via a broker. Brokers’ fees of 6% of the total issue price of those shares were payable. No fees are payable in relation to the other 11,734,175 ordinary shares that were issued in accordance with either ASX Listing Rule 7.1A or ASX Listing Rule 7.1.
